Due to a change in his assignment in connection with the organizational change other than those in the fundamental structure as described below.

II. Organizational change other than those in the fundamental structure (as of April 1, 2014)

As of April 1, 2014, the Corporate Strategic Task Force will be dissolved and integrated into the Corporate Planning Department, Corporate Management Division.

The Corporate Strategic Task Force, which was established on February 1, 2013, has engaged principally in promoting the systematization, and enhancing the values, of the Group's product brands, corporate brands and group brands.
