

V Changes in the fundamental structure:

- 1. Establishment of organization
- Establishment of "Communication Strategy Division", "Lifestyle Research Office", and "Sports Community Department"

We will establish "Communication Strategy Division", and under that, "Lifestyle Research Office", and "Sports Community Department", in order for the business of Nipponham Group to be better understood by our stakeholders such as consumers, local communities, business partners, shareholders, investors, and employees and to reflect various views from the stakeholders to our management of the business. We also will rename "Public & Investor Relations Department" under the control of Corporate Management Division to "Corporate Communications Department" and transfer it to "Communication Strategy Division" together with "CSR Department".

"Lifestyle Research Office" will deepen our understanding of consumers, and will investigate and explore so that the products and services provided by Nipponham Group could become more valuable items for consumers.

"Sports Community Department" will supports professional and amateur sports in order to promote one of the Nipponham Group's five material issues of CSR: "Supporting mental and physical well-being through food and sport", and we will utilize the knowledge gained through these activities to provide products and services.

"CSR Department" will actively cooperate and work with each business division in the Company and each section of "Communication Strategy Division" in order to contribute to society as a corporate citizen.

"Corporate Communication Department" will send integrated information of Nipponham Group to various stakeholders and further strengthen the group brand.

• Establishment of "Group Sales Planning Department"

We will newly establish "Group Sales Planning Department" for the purpose of creating a strong group synergy by mutually utilizing and integrating the strengths of each "Processed Foods Business Division", "Fresh Meats Business Division", "Affiliated Business Division" and "Overseas Business Division".

• Establishment of "Operations Management Division, Overseas Business Division"

We will integrate the three regional operation divisions, "Asia & Europe Operations Division", "Americas Operations Division" and "Australia Operations Division" under the control of "Overseas Business Division", and will newly establish "Operations Management Division" for the purpose of accelerating overseas market development. We will plan strategies for oversea operation development, from the axis of our products in addition to the axis of the area, and we will implement such strategies expeditiously.

2. Abolition of organization units

• Abolition of "Sales & Marketing Division"

We will abolish "Sales & Marketing Division" for the purpose of optimizing the operations within the Processed Foods Business Division, and for the purpose of speeding up the decision making process as well as the implementation of decisions. We will delegate authority to each sales division, clarify responsibility, and further strengthen cooperation between sales division and production division.

• Abolition of "Corporate Strategy Development Office" and "Corporate Communication Office"

We will integrate functions of Corporate Strategy Development Office" to "Group Sales Planning Department" and "Corporate Planning Department", and integrate function of "Corporate Communications Office" to "Group Sales Planning Department", "Sports Community Department" and "Corporate Communications Department" whereby the both organizations will be dissolved to have a better organizational structure.

- 3. Change of the control of organization units
- Transfer of "Corporate Planning Department" under the control of Corporate Management Division to the direct control of management and transfer of "Engineering Department" and "Secretarial Office" under the direct control of management to Corporate Management Division

To promote group management and strengthen the corporate governance function, "Corporate Planning Department" under the control of Corporate Management Division will be transferred to the direct control of management, and "Engineering Department" and "Secretarial Office" which are under the direct control of management will be transferred to Corporate Management Division.
