

V Changes in the fundamental structure

1. Reorganization

• Reorganization of the organization under Processed Foods Business Division on a function basis (Publicized on October 31, 2018)

To clarify the roles of the Company and its subsidiaries in the Processed Foods Business Division, the Company will be responsible for functions of marketing and governance. Current respective functions in "General Merchandise Division", "Food Services Division", "Sales Companies Operations Division", "Ham & Sausages Business Division" and "Deli & Processed Foods Business Division" will be reorganized and consolidated to "Sales Management Division" and "Product Management Division". The sales functions in the Company will be consolidated and basically transferred to the merging company below.

"Sales Management Division" will capture the changes of consumers and environment, and propose products and services which satisfy the needs in an appropriate way, by means of strategic sales development, promotion and new channel development, etc.

"Product Management Division" will make efforts to develop new technologies and manufacturing method to enhance product quality and productivity, and to enhance the quality assurance system, in addition to product developments from consumers' point of view.

[Summary of the merging company]

As to the new company of Nipponham East Sales Ltd. as the absorbing company to which Nipponham Hokkaido Sales Ltd. and Nipponham West Sales Ltd. will be merged as the absorbed companies, as publicized in the "Notice of Reorganization of the Processed Foods Business Division and Merger of Sales Companies (Consolidated Subsidiaries) " on October 31, 2018, the name will be "Nipponham marketing Ltd" and Hidenori Yoshimoto, the current President and Representative Director of Nipponham East Sales Ltd., will remain the President and Representative Director of the new Company.
