

V Changes in the fundamental structure

- 1. Establishment of new organizational unit
- New establishments of "Corporate Planning Division" and "Business Innovation Department"

To strengthen the function of planning and promoting management strategies as well as to respond to group management issues and changes of the external environment in a prompt and appropriate manner, "Corporate Planning Division" is to be established, under the umbrella of which "Corporate Planning Department", "IT Strategy Department", "Engineering Department" and "Business Innovation Department" are to be transferred or newly established.

"Business Innovation Department" will establish the basis for promotion of the digital transformation in addition to making efforts to standardize and streamline the business process through the reform of the business system of the group as a whole. Also, it will aim at incubations of new businesses.

2. Reorganization

• Change of name of "Affiliated Business Division" to "Dairy & Marine Products Division" and its consolidation to Processed Foods Business Division

To strengthen the dairy and marine products as well as to clarify the business domain, "Affiliated Business Division" will change its name to "Dairy & Marine Products Division" and will be consolidated to Processed Foods Business Division. The uniqueness of Affiliated Business Division and the capabilities for products development and sales of Process Foods Business Division to channels such as mass retailers, CVS, restaurants and home-meals will be fused, and the synergies will be created.

• Transferring a production and sales company of fresh meat processed products and fresh meat extracts to Processed Foods Business Division

To streamline the production system of fresh meat processed products and cooked food products, etc., a production and sales company of fresh meat processed products and fresh meat extracts is to be transferred to Processed Foods Business Division. We will, in addition to enhancing the production efficiency at Processed Foods Business Division, expand the variations of products which can be offered to customers and enhance the capability of sales.

Consolidation of "Group Sales Planning Department" and "Sports Community Department"

The function of "Group Sales Planning Department" will be consolidated to "Sports Community Department".

- 3. Change of control of organization unit, abolition and change of names thereof
- Change of control of departments at "Corporate Management Division"

Departments other than "IT Strategy Department" and "Engineering Department" in "Corporate Management Division" are to be changed to be directly controlled by the President and Representative Director and "Corporate Management Division" is to be abolished.

• Change of name of "CSR Department" "CSR Department" is to be changed to "Sustainability Department".
