

#### IV. Changes in the Fundamental Structure

- 1. Establishment and abolishment of organizational units
- Abolishment of "Overseas Business Division"
  In order to accelerate and strengthen the collaboration of our processing technology and human resource rotation to achieve the "Global strengthening" set forth in the growth strategies of the Medium-Term Management Plan 2026, we will abolish the "Overseas Business Division" and reorganize into two business divisions, the Processed Foods Business Division and the Fresh Meats Business Division.
  - In line with this reorganization, all overseas associated companies and overseas affiliated companies under the jurisdiction of the Overseas Business Division will be transferred to the "Overseas Management Division" under the Processed Foods Business Division and the "Imported Fresh Meats Sales Division" and the "Australia Business Department" under the Fresh Meats Business Division, respectively.
- New establishment of "Overseas Management Division" In order to expand the processing business in the high-growth markets of North America and ASEAN countries, the "Overseas Management Division" will be newly established within the Processed Foods Business Division to accelerate and strengthen the collaboration of processing technologies cultivated in the domestic business, the development of main brands represented by "Schau Essen" and co-creation outside the Company. The new division will be given jurisdiction of the fifteen overseas companies for processing production business and sales.
- New establishment of "Australia Business Division"
   In order to stabilize profits by strengthening domestic and overseas sales of branded beef amid rising global demand for Australian beef, the "Australia Business Division" will be newly established within the Fresh Meats Business Division, and the jurisdiction of the six Australian meat business companies will be transferred.
- New establishment of "VBM Promotion Office"
   The VBM Promotion Office will be newly established and for the purpose of strengthening the function of management resource allocation and enhancing information dissemination and communication with investors for rational securities price formation in the capital market, a portion of the functions of the Corporate Planning Department and the Public & Investor Relations Department will be transferred.
   (VBM: Value Based Management, corporate value creation management)
- 2. Name change of organizational unit
- Name change of "Business Development & Strategy Division"
  In addition to the cross-business strategy, the "Business Development & Strategy Division" will be renamed the "Business Strategy Division" and the "Business Development & Strategy Office" will be established within the division in order to promote collaboration and co-creation with companies outside the Group, leading to the creation of new value.
- Name change of "Public & Investor Relations Department"
  In conjunction with the establishment of the "VBM Promotion Office," the "Public & Investor Relations
  Department" will be renamed the "Public Relations Department" to transfer its investor relations function.
- 3. Change of jurisdiction of associated companies
- Change of jurisdiction of overseas associated companies
   With the abolishment of the "Overseas Business Division" as described above, the jurisdiction over the four fresh meats trading companies and the poultry production and sales company in Turkey will be

transferred to the "Imported Fresh Meats Sales Division" in order to strengthen business collaboration, including personnel rotation.
